BHOPAL: Madhya Pradesh faced a strange situation when both the ruling party and main opposition party took to streets to protest against each other. The demonstration in the state capital was headed by former Union minister Suresh Pachauri, State Mahila Congress President Mandvi Chouhan and district Congress president Kailash Mishra.Congress leaders and workers gathered at the Roshanpura Square, held a protest meeting for nearly two hours. Later, the party leaders marched towards Raj Bhavan to submit a memorandum to governor Lalji Tandon. The memorandum was addressed to President Ramnath Kovind seeking his intervention for getting the fund released by the Union government for flood relief work. However, the march was stopped by police near the Raj Bhavan where party workers raised anti-BJP slogans and jostled with men-in-uniform. Congress leaders were informed that Lalji Tandon is not in town. Hence, a delegation of Congress leaders, including Suresh Pachauri, walked to the governor's office and submitted the memoran-
