- 1. The Company has furnished a corporate guarantee for Diviniti Projects Private Limited (DPPL), a wholly owned subsidiary of the Company in favour of Indiabulls Housing Finance Limited (IHFL), in consideration of IHFL having sanctioned to DPPL, a term loan of Rs.55,00,00,000/- (Rupees Fifty Five Crores). The Company has also provided security to IHFL for the loan availed by DPPL, by way of pledge of its entire holding of the equity shares in the share capital of DPPL.
- The Company has jointly with other co-promoters / co-venturers, provided a corporate guarantee for Rare Townships Private Limited (RTPL), a joint venture of the Company, in favour of LIC Housing Finance Limited (LICH FL), in consideration of LICH FL having sanctioned to RTPL, construction finance loan of Rs.250,00,00,000/- (Rupees Two Hundred Fifty Crores). The Company has also provided security to LIC HFL for the loan availed by RTPL, by way of pledge of its entire holding of Class 'A' equity shares in the share capital of RTPL.
