ED attaches Thane flat in name of Kaskar's aide

The action has been taken in a 2017 extortion case filed under the PMLA

The Enforcement Directorate (ED) has provisionally attached a flat worth nearly Rs 55 lakh in Thane, held in the name of Mumtaz Ezaz Shaikh, a close associate of Iqbal Kaskar, under the Prevention of Money Laundering Act (PMLA) in an extortion case of 2017. Kaskar, being underworld gangster Dawood Ibrahim's brother, had extorted one flat in Thane from a builder in the name of Shaikh.

The ED had initiated a money laundering investigation on the basis of an FIR registered in September 2017 registered against Kaskar, Shaikh and another gangster Israr Ali Jamil Saiyad, for extortion under various sections of the Indian Penal Code (IPC). After conducting the investigation, a final report in the case was filed in November 2017 by Kasar-

vadvali police station under the provisions of the Maharashtra Control of Organised Crime Act and the IPC. An ED official said that their investigation has revealed that complainant builder, Suresh Devchand Mehta,

was running the business of construction with his partner through his firm M/s Darshan enterprises. He said Kaskar, Sheikh and Saiyad, used their underworld influence to extort the flat from Mehta.

He added that besides the flat, four cheques totalling to Rs 10 lakh were demanded by the accused and were cashed. These accounts were operated only for withdrawing the cash amount of Rs 10 lakh and no other transactions were carried out in these accounts, the ED official said, adding that the accounts were operated to hide the real user of the extorted amounts. It was also revealed that the accused also extorted cash from Mehta during that period.

The ED had arrested Kaskar on February 18 this year, for his alleged involvement in the offence of PMLA registered by the agency and is at present in judicial custody.

Water for all policy: Call all MLAs to meeting: BJP MLA

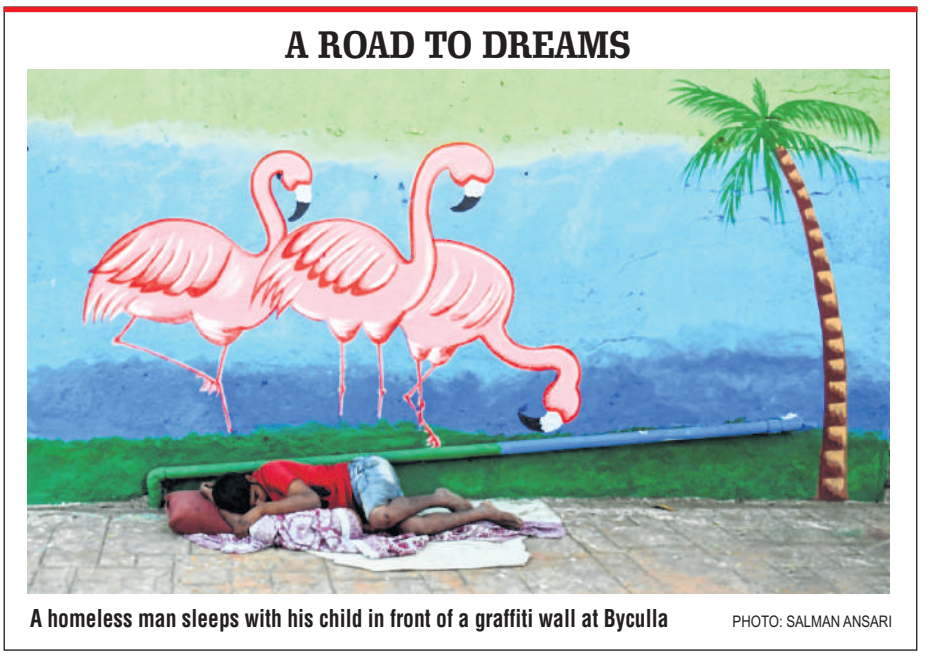
A day after state environment minister Aaditya Thackeray declared the BMC's 'water for all' policy, the BJP has come out against the civic body. BJP MLA Yogesh Sagar wrote to BMC commissioner Iqbal Singh Chahal, requesting that all the MLAs of Mumbai should be called to discuss the issue of equal distribution of water.

In the letter, Sagar has objected to calling Aaditya for the meeting related to water supply. He said, "As the administrator, you are calling some ministers to please them. Instead, you must call all MLAs to discuss the water crises of the city."

Sagar also said in the letter that he has raised this issue in the lower house of the Maharashtra state assembly. "I was a corporator in 2000, and since then I have been talking about this issue and raising it in the standing committee of the BMC. Equal water distribution should happen as per the density of population in the city and the suburban areas." He said when he became an MLA in 2009, he had raised this issue on the floor

of the state assembly. "Even today, if there is any issue related to water, officials from the BMC's department seek my help and discuss the issue with me," he has said in the letter.

Sagar also stated that when Devendra Fadnis was chief minister, he had made a presentation to the BMC's committee of experts regarding the water issue and the said committee had presented its report to the BMC and the state government.

City agents in ED crosshairs for facilitating e-gambling

Following the Enforcement Directorate (ED)'s swoop, spanning Mumbai, Delhi, Kolkata and Goa, against club managers or agents, who facilitated online betting, involvement of city-based agents have cropped up during the course of investigation.

The arrests are part of the ED's probe into a money laundering case linked with illegal online gambling. Recently, the ED officials arrested two persons from Kolkata under the Prevention of Money Laundering Act (PMLA) for allegedly operating unions on 'PP Poker', an online gaming app, and placing illegal bets virtually.

The agency had initiated the money laundering probe on the basis of an FIR registered by the Goa

police for illegal gaming activities and siphoning off huge money through secret networks, which caused loss to the government exchequer.

"The ED's investigation revealed that the Kolkata duo were operating unions such as Checkraise, Mini-India, Russian Poker, etc on PP Poker. Under each union, it is seen that around 25-30 clubs are being operated by different individuals. Through these clubs, individual players are invited via WhatsApp for placing illegal bets," said an ED official.

The commissions ranging from 5 per cent to 10 per cent were generated on each table running in the said clubs or unions, the official explained, adding that the commissions' settlement and the betting amount is done mainly through hawala operators in cash or through crypto.

In search of courier firm, elderly woman loses Rs 4.7L

A Juhu-based octogenarian homemaker was recently duped to the tune of Rs4.7 lakh by an imposter on the pretext of assisting her to send a parcel by courier. A case has been registered at the Juhu police station. According to the police, when the complainant was looking up a courier service on a local search engine, she fell prey to the Google listing fraud and contacted a fraudster, who posed as the courier service company executive. The incident occurred on April 6 as the fraudster accessed her banking details by asking her to wire Rs 10. The fraudster kept the victim busy with idle talk and tricked her into disclosing her bank details. The unidentified accused told the woman that in order to send the parcel, she would have to pay Rs 10 as a registration fee.

Will lend an ear to issues not before SC, says HC during PIL hearing

While hearing a PIL by city-based psychiatrist, Dr Harish Shetty, seeking to implement the Mental Healthcare Act, 2017, the Bombay High Court (HC) on Tuesday said that it will deal with issues which are not before the Supreme Court.

A division bench of Justices S S Shinde and Sarang Kotwal then asked Shetty's advocate, Pranati Mehra, to separate the issues in the PIL from those before the SC.

Shetty's PIL has urged the implementation of the Mental Healthcare Act, 2017 in Maharashtra, averring it pro-

tections rights of persons with mental illness and allows them to approach the Mental Health Review Boards so as to seek discharge from mental health institutions.

The psychiatrist has highlighted the plight of several patients who have to languish in the mental hospitals/ insti-

tutions even after they are cured since their families refuse to take them back. Mehra pointed out to the court that the PIL was inspired by the case of a woman who had spent over 12 years in a mental institution despite being recovered. Adding to her ordeal, her husband refused to live

with her again. Advocate General Ashutosh Kumbhkon, appearing for the state government, informed the court that a contempt petition is pending in the SC for non-compliance of its 2016 directions related to mental health, and the apex court is monitoring the compliance.
